

ACCEPTABLE USE POLICY

This Acceptable Use Policy sets out the terms between you and us under which you may access our website www.besecuremail.com (the “Website”) and send email utilising our service.

This policy applies to all users of, and visitors to, our Website.

As part of Our Services We provide You with access to and use of the following adapters (the “Adapters”) in order to send email:

- an Email Plug-in;
- a Mobile App; and
- an enterprise adapter for use by commercial Users,

Your use of our Website or one, or more, of our Adapters means that you accept, and agree to abide by this policy and any other policies referred to within it.

The Website and Adapters are operated by **Mailock Limited** and Beyond Encryption Limited (“We / Us”). We are companies registered in England and Wales under company numbers **05763590** and **8814096** respectively at Town Quay House, 99 Gosport Road, Fareham, Hants. PO16 0PY. PROHIBITED USES

You may use our Website or Adapters only for lawful purposes.

You may not use our Website or Adapters:

- In any way that breaches any applicable local, national or international law or regulation.
- In any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose or effect.
- For the purpose of harming or attempting to harm minors in any way.
- To send, knowingly receive, upload, download, use or re-use any material which does not comply with our content standards.
- To transmit, or procure the sending of, any unsolicited or unauthorised advertising or promotional material or any other form of similar solicitation (spam).
- To knowingly transmit any data, send or upload any material that contains viruses, Trojan horses, worms, time-bombs, keystroke loggers, spyware, adware or any other harmful programs or similar computer code designed to adversely affect the operation of any computer software or hardware.
- As an individual or company for email broadcast or high volume activity that may be automated or manually initiated.

You also agree:

- Not to reproduce, duplicate, copy or re-sell any part of our Website.
- Not to access without authority, interfere with, damage or disrupt:
 - any part of our Website;
 - any equipment or network on which our Website is stored;
 - any software used in the provision of our Website; or
 - any equipment or network or software owned or used by any third party.
- To only register email addresses that are associated with / controlled by you

INTERACTIVE SERVICES

We may from time to time provide interactive services on our Website, including, without limitation, chat rooms and bulletin boards (“interactive services”).

Where We do provide any Interactive Service, We will provide clear information to you about the kind of service offered, if it is moderated and what form of moderation is used (including whether it is human or technical).

We will do our best to assess any possible risks for users (and in particular, for ‘minors’) from third parties when they use any Interactive Service provided on our Website, and We will decide in each case whether it is appropriate to use moderation of the relevant service (including what kind of moderation to use) in the light of those risks. - Promote any illegal activity.

- Be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety.
- Be likely to harass, upset, embarrass, alarm or annoy any other person.
- Be used to impersonate any person, or to misrepresent your identity or affiliation with any person.
- Give the impression that they emanate from us, if this is not the case.
- Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

SUSPENSION AND TERMINATION

We will determine, in our discretion, whether there has been a breach of this policy through your use of our Website. When a breach of this policy has occurred, We may take such action as We deem appropriate.

Failure to comply with this policy may result in our taking all or any of the following actions:

- Immediate, temporary or permanent withdrawal of your right to use our Website.
- Immediate, temporary or permanent removal of any posting or material uploaded by you to our Website.
- Issue of a warning to you.
- Legal proceedings against you for reimbursement of all costs on an indemnity basis (including, but not limited to, reasonable administrative and legal costs) resulting from the breach.
- Further legal action against you.
- Disclosure of such information to law enforcement authorities as We reasonably feel is necessary.

We exclude liability for actions taken in response to breaches of this policy. The responses described in this policy are not limited, and We may take any other action We reasonably deem appropriate.
